EXPLANATION

The foregoing consent is revocable by the member in a writing received by the association, provided however, that such revocation is effective with respect to patronage occurring after the close of the association's fiscal year during which said written revocation is received. THE PATRONS/MEMBER'S CONSENT IS REQUIRED FOR THE COOPERATIVE TO RECEIVE AN INCOME TAX DEDUCTION FOR ITS PATRONAGE ALLOCATIONS, pursuant to Subchapter T of the Internal Revenue Code of 1954, Sections 1381 through 1388. By signing said consent the patron agrees to include the total amount of any patronage allocation or dividend (not just the cash portion thereof) in his/her gross taxable income in the year during which qualified written notice of allocation is received. While you are required to sign the foregoing consent, it relates to you only to extent that your purchases from the association or sales to the association are related to your taxable income.
